AIR TRANSPORTATION from Chicago and return via SWISS Airlines or other scheduled carriers. The airfare included in the tour price is the lowest applicable fare at the time of printing, August 2005, and is subject to change without notice.

ACCOMMODATIONS are in Superior First Class & Deluxe hotels, in twin-bedded rooms with private facilities. You will receive a detailed list of all the accommodations on your tour, including addresses and telephone numbers, with your travel documents.

MEALS are buffet breakfast and dinner daily. During the conference in Jerusalem, meals are breakfast lunch and dinner daily. Beverages are not included except coffee and tea with breakfast.
