Incentive Trip Terms & Conditions

1. The purchasing period for this incentive trip is January 1st 2014 through December 31st 2014 . Purchases from previous or future time periods/dates will not be considered towards the amount needed to be ticketed for this incentive trip. You cannot bank or save purchases for future years' incentive trips.
2. Your account must be current as of January 1st 2015 to be ticketed for this incentive trip.
3. This incentive trip has no monetary value. This trip is an incentive offered to Peabody Supply Co. customers with accounts in good standing.
4. Ticketing for this incentive trip is subject to returning all required paperwork, meeting all deadlines, making all required payments, as well as the discretion of Peabody Supply Co., a division of Hajoca Corp.
5. All incentive trip payments of any kind made to Peabody Supply Co. must be made by check, payable to Peabody Supply Co. Cash or credit card payment is not acceptable. Applying trip charges to a customers Peabody Supply Co. credit account is not acceptable.
6. All ticketing is based on double occupancy rooms; two tickets per room. If one person will be occupying a room, an additional charge (the difference between the rate per person for a double occupancy room and rate for a single occupancy room) will be due on Friday January 16th 2015.
7. Incentive trip "buy in" is available after spending \$50,000. A final statement will be mailed out January 1st 2015 with your total number of trip tickets earned as well as your cost to buy in if you purchased \$50,000 or more but less than \$90,000. You may also "buy in" your second, third, and fourth ticket if a first ticket is earned. For Example: if you spend more than \$90,000 but less than \$190,000 and qualify for the first ticket, you must pay the unearned percentage of your second ticket at a rate of \$1,779 per adult and \$1,450 per child under 12. If you will be buying into the trip, a check made payable to Peabody Supply Co. must be received for the amount due by January 16th 2015 in order to be ticketed.
8. Customers who have spent less than \$90,000 and are considering buying into the incentive trip based on the November 2014 statement, MUST fill out the Trip Incentive Ticketing & Passport Form in order to be considered for ticketing. If, in the event you choose not to buy in, you may retract your Trip Incentive Ticketing & Passport Form By January 16th 2015 with no service fees assessed. Any forms submitted, changed or retraced after January 15th 2014 are subject to a \$100 service fee.
9. All funds paid to Peabody Supply Co. through the buy in program are non-refundable after January 16th 2015. Furthermore, after January 16th 2015 any funds paid to Peabody Supply Co. are forfeited if you do not travel and are subject to the service fees of the Incentive Trip Ticketing & Passport Form, as well as cancellation fees.
10. Additional tickets may be purchased for this incentive trip at the rate of \$1,975.00 net per person in twin/double sharing & \$359.00 single supplement and \$1,295.00 net per child under 12 at time of travel. All additional tickets must be paid for by check made payable to Peabody Supply Co. before January 16th 2015 to be ticketed. All those who will be joining the trip by paying for a ticket in full, must submit the Ticketing & Passport Form by December 19th 2014 in order to be ticketed. If, in the event you choose not to purchase a ticket in full, you may retract your Trip Incentive Ticketing & Passport Form by January 16th 2015 with no service fees assessed. Any forms submitted, changed or retracted after January 16th 2015 are subject to a \$100 service fee.
11. Purchasing the required amount from Peabody Supply Co. does not qualify you for the trip. The Incentive Trip Interest Form must be filled out prior to May 31st 2014 to be considered. All customers will be ticked per the discretion of Peabody Supply Co. Travel is not guaranteed to any Peabody Supply customer.
12. The Incentive Trip Ticketing & Passport Form must be returned to Peabody Supply Co. by December 19th 2014 in order to be ticketed for this trip. Only one submission will be accepted per shop. Late submissions forfeit any ticketing. Incomplete, unsigned, or inaccurate forms are considered void.
13. Peabody Supply Co. will asses the following service fees in the following circumstances: A) Any changes that differ from the original submitted Trip Ticketing & Passport Form and any changes made after January 16th 2015- \$100 per change B) Any trip cancellation after January 16th 2015 - \$600 fee per ticket submitted on the Ticketing & Passport Form. By Submitting the Trip Ticketing & Passport Form you agree to the service fees above.
14. All Peabody Supply Co. accounts agree to the Terms and Conditions of this incentive trip. Any previous years terms and conditions of this trip are void. By signing and submitting your Incentive Trip Interest Form you agree to these terms and conditions.
15. Travel is not guaranteed at any point. All incentive trip location and dates are subject to change. Any funds paid to Peabody Supply Co. are forfeited after January 16th 2015, under no circumstances will a refund be given for any funds paid after that date.
16. Peabody Supply Co. is not responsible for any inconveniences changes may cause, any lost or stolen items, any damages of any kind, as well as any injury or loss. Peabody Supply Co. is not responsible for any additional customer charges, not included in the trip package, while traveling.
